ORDINANCE #1607

Energy Aggregation

AN ORDINANCE OF THE BOROUGH OF KEANSURG, COUNTY OF MONMOUTH, STATE OF NEW JERSEY, AUTHORIZING THE ESTABLISHMENT OF A GOVERNMENT ENERGY AGGREGATION PROGRAM

WHEREAS, the Government Energy Aggregation Act, <u>N.J.S.A.</u> 48:3-93.1 *et seq.* governs the establishment of a government energy aggregation program, which is a government-operated purchasing cooperative through which multiple energy consumers purchase energy together under the auspices of a government aggregator; and

WHEREAS, the New Jersey Board of Public Utilities ("BPU") has promulgated rules (N.J.A.C. 14:4-6) for the implementation of government energy aggregation programs; and

WHEREAS, pursuant to the Government Energy Aggregation Act, N.J.S.A. 48:3-93.1 *et seq.*, the Borough seeks to establish a Government Energy Aggregation Program ("Program") for the provision of electricity within the Borough, for the purpose of obtaining power supply cost savings for residential and business participants in the Borough; and

WHEREAS, the Borough Council intends to serve as the Lead Agency conducting a Government Energy Aggregation Program in the Borough of Keansburg and, in that capacity and consistent with applicable rules, to solicit proposals and enter into a contract for the provision of electric generation services on behalf of residential and/or business customers within the boundaries of the Borough, to the extent that such a contract will produce power supply cost savings to residents and businesses; and

WHEREAS, the Borough Council will from time to time during the Effective Period as defined below solicit proposals from electric power suppliers for electric generation services through the Program in which the Borough Council will act as Lead Agency of the Keansburg Community Aggregation Program ("KCEA"); and

WHEREAS, the Borough Council will from time to time during the Effective Period as defined below issue one or more Request for Proposals for electric generation services and energy



aggregation services on behalf of the KCEA pursuant to the Local Public Contract Law Regulations, the Government Energy Aggregation Act and the Electric Discount and Energy Competition Act; and

WHEREAS, the Borough Council would consider that a fraction of the energy provided by KCEA come from renewable energy sources, and will therefore include provisions for the inclusion of renewable energy in the Request for Proposals for electric generation services and energy aggregation services on behalf of the KCEA; and

WHEREAS, the Borough Council will only award contracts for said electric generation service and energy aggregation services to electric power suppliers that are deemed qualified and that submit price bids lower than the prevailing price for utility-provided basic generation service;

WHEREAS, pursuant to applicable BPU rules, the Borough needs to enter into an Electric Distribution Company Aggregation Agreement with Jersey Central Power and Light ("JCP&L") Company; and

WHEREAS, N.J.S.A. 48:3-93.1 et seq. requires the Program to be established by ordinance.

NOW, THEREFORE, BE IT ORDAINED by the governing body of the Borough of Keansburg, County of Monmouth, State of New Jersey as follows:

- **SECTION 1.** The Borough hereby establishes a Government Energy Aggregation Program, in accordance with the provisions of the Government Energy Aggregation Act, N.J.S.A. 48:3-93.1 *et seq.*
- **SECTION 2.** The Mayor and/or Acting Mayor is authorized to execute and the Clerk and/or Acting Clark to attest to the execution of and Electric Distribution Aggregation Agreement, in a form acceptable to the Borough, with JCP&L.
- **SECTION 3.** The Borough Council will act as Lead Agency of the KCEA and, in that capacity, and consistent with applicable rules, will solicit proposals for electric generation service and energy aggregation services on behalf of Borough residents and businesses, and enter into a contract for such services provided that the lowest qualified bid price is below the prevailing price for utility-provided basic generation service.
- **SECTION 4.** As Lead Agency the Borough Council will execute a master performance agreement that obligated the participants in the KCEA to purchase electricity at terms and conditions stated therein with a third party supplier who has been awarded the contract by the Lead Agency on behalf of participating members of the KCEA, and provided that such contract shall be at prices reasonably forecast and estimated by the Borough Council to provide savings to participants relative to the price charged for basic generation service by JCP&L.



SECTION 5. The authorization provided to the lead agent shall be valid until May 1, 2023 (the "Effective Period"), at which time the KCEA will be subject to renewal at the discretion of the Borough Council.

SECTION 6. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 7. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

Ordinance to Exceed The Municipal Budget Appropriation Limits and to Establish A CAP Bank (N.J.S.A. 40A:4-45.14) - Calendar year 2018

CALENDAR YEAR 2018

MODEL ORDINANCE TO EXCEED THE

MUNICIPAL BUDGET APPROPRIATION LIMITS

AND TO ESTABLISH A CAP BANK

(N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless



authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Mayor and Council of the Borough of Keansburg in the County of Monmouth finds it advisable and necessary to increase its CY 2018 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Mayor and Council hereby determines that a 1.0% increase in the budget for said year, amounting to \$141,059.94 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Mayor and Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Mayor and Council of the Borough of Keansburg, in the County of Monmouth, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2017 budget year, the final appropriations of the Borough of Keansburg shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5 %, amounting to \$493,709.82, and that the CY 2018 municipal budget for the Borough of Keansburg be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

AN ORDINANCE AMENDING CHAPTER II (ADMINISTRATION), SECTION 20 (DEPARTMENT OF PUBLIC SAFETY) OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF KEANSBURG.

Section 1:

BE IT ORDAINED by the Mayor and Council of the Borough of Keansburg that Chapter II
(Administration), Section 20 (Department of Public Safety) of the Revised General
Ordinances be amended as follows:

Section 2-20.3 Police Division Established; Composition

Shall be amended as follows:

The Police Division of the Borough of Keansburg is hereby established and shall consist of a Chief of Police, one (1) Deputy Chief of Police, two (2) Captains of Police, five (5) Lieutenants of Police, four (4) Sergeants of Police and as many regular and special policemen as the Borough Manager may deem necessary. All members of the Police Department shall be appointed, promoted and removed by the Borough Manager in accordance with State statutes. They shall, upon appointment, be assigned daily duties by the Chief of Police. The Borough Manager may also require



that an applicant for appointment to the Police Division shall successfully complete a physical, mental and psychological examination.

- Section 2: REPEALER. The remainder of all other sections and subsections of the aforementioned ordinance not specifically amended by this Ordinance shall remain in full force and effect.

Amend Fire Safety Inspection Fees

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER XIII (FIRE PREVENTION AND PROTECTION), SECTION 1.9 (ADDITIONAL REQUIRED INSPECTIONS and FEES), OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF KEANSBURG.

Section 1:

BE IT ORDAINED by the Mayor and Council of the Borough of Keansburg that Section 1.9 (Additional Required Inspections and Fees) of Chapter XIII (Fire Prevention and Protection)) of the Revised General Ordinances be amended and supplemented as follows:

i. Registration Fees for all Additional Uses.

SHALL READ:

1. Type L Uses: Forty-five (\$ 45.00) dollars every two (2) years.

2. Type M Uses: Sixty (\$ 60.00) dollars per year.

3. Type N Uses: Ninety (\$ 90.00) dollars per year.

4. Type O Uses: One hundred ten (\$ 110.00) dollars per year.



- 5. Type P Uses: One hundred thirty-five (\$ 135.00) dollars per year.
- 6. Type Q Uses: One hundred sixty (\$ 160.00) dollars per year.
- 7. Type D Certificate detector and carbon monoxide alarm compliance with N.J.A.C. 5:70-2.9 (d).

When more than one (1) additional use exists under one (1) ownership at a given location, the highest use shall be registered at full fee and subsequent use at one-half (1/2) the scheduled fee.

j. Site Plans

SHALL READ:

For the review of any site plan or subdivision for the purpose of fire prevention as to the location of fire hydrants, fire drafting stations, water mains, and fire lanes/zones the fee is one hundred-fifty (\$ 150.00) dollars.

I. Certificate of Smoke Detector and Carbon Monoxide Alarm Compliance

SHALL READ:

Before any Use Group R-3 or R-4 structure is sold, leased, or otherwise made subject to a change of occupancy for residential purposes, the owner shall obtain a certificate of compliance with N.J.A.C. 5:70-4.19.

The application fee for a certificate of smoke detector and carbon monoxide alarm compliance (CSDCMAC), as required by N.J.A.C. 5:70-2.3, shall be based upon the amount of time remaining before the change of occupant is expected, as follows:

- 1. Requests for a CSDCMAC received more than ten (10) business days prior to the change of occupant: Forty-five (\$ 45.00) dollars.
- 2. Requests for a CSDCMAC received four (4) to ten (10) business days prior to the change of occupant: Ninety (\$ 90.00) dollars.



- 3. Requests for a CSDCMAC received fewer than four (4) business days prior to a change of occupant: One hundred sixty-one (\$ 161.00) dollars.
- Section 2: REPEALER. The remainder of all other sections and subsections of the aforementioned

ordinance not specifically amended by this Ordinance shall remain in full force and effect.

Prohibition of Certain Vehicles on Borough Roadways

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER XXII (DEVELOPMENT REGULATIONS) SECTION 7.18 (GENERAL ZONING PROVISIONS; STORAGE of BOATS and RECREATIONAL VEHICLES), OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF KEANSBURG.

Section 1:

BE IT ORDAINED by the Mayor and Council of the Borough of Keansburg that Section 7.18. (General Zoning Provisions; Storage of Boats and Recreational Vehicles)) of Chapter XXII (Development Regulations)) of the Revised General Ordinances be amended and supplemented as follows:

SHALL READ:

Section 22-7.18 Storage of Boats and Recreational Vehicles.

The outdoor storage of an unoccupied recreational vehicle, motor home, travel trailer, camper or small boat shall be permitted on single family properties provided that:

- a. Travel trailer, camper or small boat shall not exceed twenty-eight (28') feet in length and eight (8') feet in width.
- b. Only one such travel trailer or camper, and one small boat shall be permitted to be stored outdoors at any single residence.
- c. Any such vehicles stored in accordance with this section shall not be occupied and shall not be provided with utility connections.
- d. Permanent or temporary overnight occupancy or use of a trailer, travel-trailer, motor home, boat or recreational vehicle is not permitted in any zone.
- e. Travel trailers, campers, boats, recreational vehicles and vehicles in excess of eight (8') feet in width are prohibited from parking on any roadway or any parking lot or property owned by the municipality.

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER VII (TRAFFIC), SECTION 3.3 (PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS) OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF KEANSBURG.

Section 1:

BE IT ORDAINED by the Mayor and Council of the Borough of Keansburg that Schedule I (No Parking) of Chapter VII (Traffic), Section 3.3 (Parking Prohibited at All Times on Certain Streets) be amended and supplemented as follows:

Entire length DELETE: CARLO DRIVE Both

ADD: CARLO DRIVE South Entire length
